The undersigned client(s) ("Client" "I" "me") hereby authorizes individual or entity identified as Agent below as my agent and attorney-in-fact ("Agent") to buy and sell and otherwise deal in equities, options on equities, commodities, commodity futures, options on commodity futures, Contracts for Differences (CFDs) and foreign exchange instruments for my account and risk ("Trading") with Tradeview Financial Markets S.A.C ("Tradeview" "you"). I hereby agree to indemnify and hold Tradeview, its employees, agents, officers and directors harmless, without limitation, from all losses, costs, indebtedness and liabilities, including reasonable professional fees arising from my Agent's Trading. I accept all risks, without limitation, associated with my Agent's use of the Cash Multi Account Manager execution/ allocation platform ("MAM Platform") designed to permit my Agent to execute orders in a single master account ("Master Account") the profit and/or loss ("P/L") from which is automatically allocated to participating sub-accounts, including my account(s) (the "Account"), connected to such Master Account(s), on a pro rata equity basis.

I understand and agree, without limitation, that notwithstanding any provision to the contrary in my customer agreement, trading information usually available on my MT4 platform for each trade will only be available to me through Tradeview's MAM viewer software ("Tradeview MAMViewer"). The final P/L from trading will be reflected on my MT4 Platform only after open positions are closed and the information on the MT4 platform is the official statement of account. The Tradeview MAMViewer is provided to me as a courtesy and is not the official statement of account. I understand that my participation percentage ("Percentage") in a trade will be established for each new trade executed for my Account. My Percentage for new trades may change if clients are added to or withdrawn from the Master Account.

I understand and agree, without limitation, that Tradeview is not liable for the accuracy, effectiveness or reliability of the MAM Platform used by my Agent and that it is my Agent's responsibility to ensure that my Account has sufficient margin to carry the positions and Percentage allocated to The Account. I further understand and agree that Tradeview has the right to set limits on My Agent's ability to manage The Master Account and to define the parameters under which my Agent is authorized to manage The Master Account. Tradeview is authorized, but not obligated, to take such action regarding. The Master Account as it may determine for the protection of Tradeview, its customers and its commercial relationships.

In all buys and sells Tradeview is authorized to follow the instructions of my Agent, its employees, sub-agents or designated third parties in every respect concerning the Master Account. I understand and agree that I may not initiate or offset trades in my Account managed by my Agent. Except as herein otherwise provided, my Agent is authorized to act for me in the same manner and with the same force and effect as I might or could do with respect to such buys and sells as well as with respect to all other things necessary or incidental thereto, except that my Agent is not authorized to withdraw any money, securities, or other property, either in my name or otherwise. I hereby ratify and confirm any and all transactions with you heretofore or hereafter made by my Agent on behalf of or for The Account. This authorization and indemnity are in addition to (and in no way limit or restrict) any rights you may have under any other agreement between you and me.

I confirm and hereby agree to my Agent's compensation for managing my Account. Tradeview shall have no liability for errors in calculating the Compensation other than to make correcting adjustments. This authorization and indemnity is a continuing one and shall remain in full force and effect until revoked by me by a written notice addressed to you, delivered to you, and acted upon by you in the ordinary course of usiness, and such revocation shall not affect Tradeview's liability in any way resulting from transactions initiated prior to such revocation. This authorization and indemnity shall inure to Tradeview's benefit and that of its successors and assigns.
